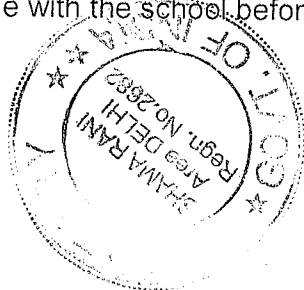
#### AFFIDAVIT

The saving, if any after meeting the recurring and non recurring expenditure and contributions to developmental, Depreciation and contingency funds, will be further utilized for promoting the school and extending the cause of education in the same school only.
5. That Air Force School Manauri is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organisation or body.
6. That Air Force School Manauri will not open classes under CBSE pater particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
7. That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination byelaws, direction issued from time to time and the law of the land.
8. That Air Force School Manauri will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc. with respect to the school and staff of the school.
9. That Air Force School Manauri will ensure that the Building Safety, Fire Safety, Water Safety, Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.
10. That Air Force School Manauri will ensure that all required infrastructure is available with the school before starting classes.
11. That Air Force School Manauri will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation bye-laws are available with the school before starting classes.

13. That Air Force School will not coerce any student/parent to buy books/stationary/uniform from any particular shop.

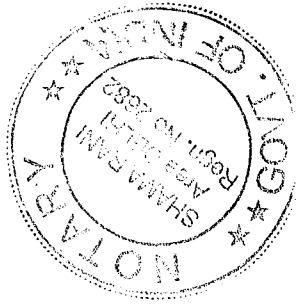
14. That Air Force School Manauri shall strive to make efforts for conservation of environment.
